5. Tenderers shall meet the minimum requirements by submitting the documents stated below:
- Local Sarawakian Tenderers participate as Single Entity registered with:
 - Company Registration/Statutory Documents (SSM Certificate/Form 9/Section 17, Form 49/Section 14 and 58, Form 24/Business Registration certificate/Section 78 and 51, Form 44/Section 46(3) and Board Resolution);
 - Has valid UPJK License [Class A, Head VII: Chartered Services or Other Services, Subhead 2a(i): Land Transport – General Trucking Services and/or Subhead 2a(ii) Land Transport – Transportation Services] issued by Sarawak State Financial Secretary Office **(if any)**;
 - The Tenderer shall have a minimum of three (3) appointed projects with a similar nature of work within the three (3) years (2022-2025).
 - For Tenderers who are **not registered** as SEDC Energy vendors is required to submit their Vendor Registration Form (Contractor / Supplier) before tender closing date.
 - The Tenderer shall comply with the following management systems for the duration of the contract:
 - ISO 39001: 2012 – Road Traffic Safety (RTS) Management Systems
